C) Committees

Currently you are a part of Audit Committee and Exit Offer Implementation Committee of the Company. Apart from this Committees, you may be required to serve on one or more committees of the Board as and when required. You will be provided with the relevant terms of reference on your appointment to such a committee. Any such appointment will be covered in a separate communication. It is expected that taking into account all other commitments you may have, you are able to, and will, devote sufficient time to your duties as a Non-executive Independent Director.

D) Expectation of the Board:

E) Code of Conduct and Duties and Responsibilities

- 2. You will not hold office as a Director or any other office in a competing firm/entity.
- 3. You are expected to say updated on how best to discharge your roles, responsibilities and duties and liabilities as an Independent Director of the Company under applicable law, including keeping abreast of current changes and trends in economic, political, social, financial, legal and corporate governance practices.
- 4. You are expected to take decisions objectively and solely in the interest of the Company and to facilitate company's adherence to high standards of ethics and corporate behavior.
- 5. Unless specifically authorized by the Company, you shall not disclose Company and business information to public constituencies such as the media, the financial community, employees, shareholders, agents, franchisees, dealers, distributors. Your obligation of confidentiality shall survive termination or cessation of your directorship with the Company.
- 6. Additionally, you shall not participate in any business activity which might impede the application of your independent judgment in the best interest of the Company.
- 7. Unless specifically authorised to do so by the Board, you will not enter into any legal or other commitment or contract on behalf of the Company.
- 8. You will disclose any direct or indirect interest which you may have in any matter being considered at a board meeting or committee meeting and you will not vote on any resolution of the Board, or of one of its committees, on any matter where you have any direct or indirect interest.

F) Performance Evaluation

Your performance will be evaluated as per the requirements of the Act and all other applicable laws for the time being in force.

G) Sitting Fees etc

You will be entitled to sitting fees for attending each meeting of the Board and its Committees as may be determined by the Board from time to time and reimbursement of expenses incurred by you in connection with attending the Board Meetings, Committee Meetings, General Meetings of the Company.

The payment of sitting fees will be within the limits mandated under the Companies Act, 2013 and Rules made thereunder (as amended from time to time). Apart from sitting fees, no payment by way of bonus, profit related commission, pension, incentives shall be made.

H) Change of personal details

During the term, you shall promptly intimate the Company Secretary and the Registrar of Companies in the prescribed manner, of any change in address or other contact and personal details provided to the Company.

I) Termination

Your directorship on the Board of the Company shall terminate or cease in accordance with law.

You may resign from the directorship of the Company by giving a notice in writing to the Company stating the reasons for resignation and also to Registrar of Companies (ROC). The resignation shall take effect from the date on which the notice is received by the Company or the date, if any, specified by you in the notice, whichever is later.

If at any stage during the Term, there is a change that may affect your status as on Independent Director as envisaged in Section 149(6) of the Act, you agree to promptly submit your resignation to the Company with effect from the date of such change.

This letter represent the entire understanding and constitutes the whole agreement, in relation to your appointment. No waiver or modification of this letter shall be valid unless made in writing and signed by you and the Company.
