The copy of letter of resignation dated September 26, 2022 is enclosed herewith for your reference.

Further, the members of the Company at the 32nd AGM held on September 26, 2022 approved the appointment of M/s. Manubhai & Shah LLP (Firm Registration No.: 106041W/W100136), Chartered Accountants, Ahmedabad as the Statutory Auditors of the Company for a period of 3 (Three) years from the conclusion of 32nd AGM till conclusion of 35th AGM of the Company,

Sub: Resignation as Statutory Auditor of the Company in view of RBI guidelines dated 27/04/2021

Dear Sirs,

We have been appointed as Statutory Auditor of the Company in the AGM for FY 2019 for conducting audit of the company for the year 2019-20 and onwards for a period of 5 years as per the provisions of section 139 of the Companies Act, 2013. We have completed tenure of 3 years (FY 2019-20, FY 2020-21 and FY 2021-22).

The Company is registered as NBFC with Reserve Bank of India (RBI) and is required to follow the guidelines issued by RBI from time to time. The Reserve Ban of India have issued Guidelines for appointment of Statutory Auditors in respect of entities governed by it vide circular no. RBI/2021-22/25 (Ref.No.DoS.CO.ARG/SEC.01/08.91.001/2021-22) dated 27-Apr-2021. As per para 8.1 of these guidelines, the statutory auditor has to be appointed for continuous period of 3 years (subject to audit firm satisfying eligibility norms). Thus, the Company is required to rotate the statutory audit after a period of 3 years as against 5 year period specified under Companies Act, 2013.

To ensure compliance with aforesaid RBI guidelines, as we have completed three years tenure, we are tendering our resignation as Statutory Auditors of the Company. We shall be retiring with the conclusion of AGM being held on 26/09/2022. We place our thanks for cooperation extended by the management during our tenure for smooth conduct of the statutory audit.
